# **The Brands**

## **AFAM Incorporated**

Grand Lodge was incorporated as AFAM Incorporated many years ago. As part of that process, we retained the Almoners Fund as a sub-committee of the Board of Management. This is to assist Freemasons internally.

### Freemasons Foundation & Freemasons Charity Management

The Freemasons Foundation is one of the Freemasons oldest benevolence entities combined with the new Freemasons Charity Management and its suite of Deductible Gift Recipients (DGR) entities allows for scholarships, education grants, History and Literary Grants and health promotion activities.

## **Masonic Charities Trust**

Newly created after the sale of Masonic Homes which is a registered Charity as a Public Ancillary Fund (PAF). This Charity donates to registered DGRs every year a percentage of its total corpus.











# **Key Changes**

## Under the one roof

All benevolence has been centralised under one roof using Masonic Services. This allows for the best coordination of resources and ensures no double, or in some cases triple handling takes place.

The creation of a new Advisory committee called the **"Freemasons Charitable Distributions Committee" (FCDC)** has allowed for all applications to be reviewed using a simplified templated tool with all the organisation's objectives taken into consideration.


Previously Charities would approach the organisations acting as silos for approval and consideration of funds and in some cases either doubling up or not aligning with the general wishes of the membership.

Under the new approach the Funds are held under specific criteria with budgets that the lodges are able to support and put forward to the FCDC and Masonic Services for compliance check and review. They will then produce recommendations to the Boards for approval and final sign-off if successful.

# I NE Process

# All Applications to follow the same process

To ensure that benevolence areas are aligned to the membership and the funds the new process from 2024 is as follows:

- Considerable funds are available for benevolent distribution to worthy charities, organisations or individuals.
- The current process has been simplified to four steps.
- Paper based applications forms are no longer accepted.
- There are currently 4 funds accepting applications:
  - The Health Promotion Fund;
  - The History & Literary Trust;
  - The Freemasons Foundation; and
  - The Freemasons Foundation Scholarship Trust (individuals only).





# Step 1

A Lodge is approached by - or may approach a charity, organisation or individual seeking assistance.

- Lodge members can nominate worthy groups within their communities or in any area of SA & NT.
- The lodge does not need to be located in the same area as a charity, organisation or individual to offer support, just in SA & NT.

# <u>Step 2.</u>

#### Discuss the request at the Lodge Executive Meeting.

- Should the Lodge wish to support a cause:
  - Fill out the Lodge Letter of Support Form. Download Here
  - One form for each charity, organisation or individual.
  - Include full details of the request & the amount sought.
  - Have the Master, Secretary or the Treasurer sign the Lodge Letter of Support (minimum of 2 to sign).
  - Continue to Step 3.
- Should the Lodge not wish to support a cause:
  - Notify the organisation via email or phone of this noting that there is no requirement to provide a reason.
  - No further action required from the Lodge.

## Step 3.

- Forward the completed Lodge Letter of Support Form to the charity, organisation, or individual:
  - Ask them to add the details and complete the application online at: <u>https://santfreemasons.org.au/applications-for-</u> <u>benevolence/</u>



## Step 3. continued\_

- Should they encounter difficulties adding an application online advise them to contact <u>admin@masonicservices.com.au</u> or <u>1300 357 999.</u> The team will offer all assistance from here on.
- The onus is on the charity, organisation or individual to lodge an application online, **not the Lodges.**
- Noting ANYONE can add an application online, as long as they have a signed Lodge Letter of Support. A lodge member may choose to add an application for an organisation, however forwarding to the organisation is recommended as they will know all the details required.
- Once a completed application is received:
  - Admin staff will verify the application is complete or seek additional information if required.
  - The FCDC (Freemasons Charitable Distribution Committee) meet in May and November to discuss applications.
  - The FCDC recommendations are forwarded to the Freemasons Foundation and Freemasons Charity Management Board for final approval.

## Step 4.

#### • Outcome and Decisions

- Once a decision has been made by the boards, the charity, organisation or individual along with the supporting Lodge are notified of the outcome.
- Lodges needing assistance with the process or any additional questions are encouraged to contact us via email at <u>admin@masonicservices.com.au</u> or call 1300 357 999.
- There are two intakes each year as follows:
  - Applications to be in for round 1
    - 1st November to 20th April each year.
  - Applications to be in for round 2
    - 1st May to October 20th each year.

## **Frequently Asked Questions**

#### Can a lodge support more than 1 organisation?

Yes – this is encouraged.

#### Can a lodge support outside their area?

Yes, so long as the organisation operates in SA/NT and the project will be within SA/NT.

#### Can an organisation have multiple lodges supporting them?

Yes, this spreads it around the lodges. Furthermore, if an organisation has multiple projects in multiple regions the support can be split over multiple lodges.

# Do lodges have to support every organisation that requests funding?

No – it is up to the lodge however if the lodge is not supporting an organisation, it wouldn't be in keeping with the model of Benevolence, which is to support successful projects and help the community achieve their goals. Therefore, it is suggested that you give consideration to requests.





# **Frequently Asked Questions**

#### Can a lodge go out to organisations and offer support?

Yes, we encourage lodges to do this providing they meet the criteria as outlined in this brochure.

#### Does a lodge have to reply to all requests?

Yes – If your lodge has already been approached and the lodge is supporting other organisations then it would be beneficial for that lodge to help suggest another lodge that is not currently supporting anyone.

#### Can a lodge offer support with 2 year or 3 year fundings?

No, we no longer support multiyear funding. It is a once off donation to the organisation for their project.

#### Can a lodge offer support for vehicles i.e. buses, cars, vans etc?

No, we no longer do these types of donations due to the fact of upkeep on vehicles and protection of the Square & Compass logo.

# Where can lodges direct an organisation if they need another lodge to support them?

The website has the lodge locator link for them to click (also available on page 6 of this document).





# **Frequently Asked Questions**

# Do all organisations have to have a lodge letter of support to apply?

Yes, without the lodge letter of support the application will not progress. Lodge letters of support must be included in the initial online application and cannot be provided retrospectively.

#### Can an interstate lodge complete a lodge letter of support for an organisation based in SA & NT?

No, only SA & NT lodges can support organisations who provide services within SA & NT.

# Can an organisation who is based in another state request support from a lodge?

Yes, some head offices are based interstate but still provide services in SA & NT. However, the project to be funded must be in SA & NT.
